**Timed Pace** sections will be approx. 2-4K each on public limerock roads. There will be an optimum time posted and the object is to come in right on time. Any over or under seconds are penalized at 1/2 point per second.

**Dressage** ADS "B" (80m) tests for each level (training/prelim/intermediate) Find tests at www.americandrivingsociety.org>events & resources>resources

**Cones** are timed for two minutes. Do as many sets of cones as possible, in any order (except do not repeat a set of cones without going through another set first). When the whistle blows at the end of two minutes, head for the start/finish cones. Knocked down balls means that set of cones doesn't count, and can't be driven again. *Please no cantering.* 

Each phase of the competition brings you to the next phase. The Timed Paces will be marked with arrows. Pace #1 ends at Dressage then Pace #2 will take you to Cones.

### FLORIDA WHIPS RULES OF THE ROAD:

- 1. Vehicle and harness must be serviceable and in good repair
- 2. Horses must have bridles on with reins attached prior to hitching to a vehicle
- 3. Vehicles must be unhitched prior to removing reins and bridle
- 4. Never tie a horse or leave it unattended when hitched to a vehicle
- 5. Driver must always have a whip and carry it while in motion
- 6. Never pass another carriage at a fast trot and never drive too close to another driver

### ADDITIONAL RULES AND REQUIREMENTS:

Classes in general will follow the spirit of the ADS rules.

Leaving horses unattended while put-to a vehicle, or removing bridle, or detaching the reins from bridle before unhitching is prohibited. Failure to comply will result in instant elimination without refund.

Junior competitors under the age of 18 must wear a helmet, and those under the age of 14 must be accompanied by a competent adult at all times.

Organizer has the right to (1) cancel any division or classes with less than two entries; (2) split or combine divisions or classes; (3) Add classes to accommodate entries; and (4) has the right to cancel show for lack of entries.

Full turnout is optional, gloves and aprons recommended. Helmets are required for all timed classes (cones and obstacles). An appropriate driving whip shall be carried in hand at all times while driving. Marathon vehicles permitted for Pleasure Classes.

Pneumatic Wheels are permitted at the Organizer's discretion

It is the competitor's responsibility that all animals are serviceably sound and that harness is in good repair and the vehicle in sound condition. Any questions or disputes will be addressed by the Judge. The Judge's decision is final.

The consumption of Alcohol is not permitted at any Whips Events for insurance purposes.

All dogs must be leashed.

Any reckless driving that endangers oneself or fellow competitors will result in elimination.

Overuse of the whip will be penalized.

• The entities described above, including Florida Whips, Inc. and any sponsors, property owners, or additional insureds, and or equine professionals associated with the above described events (collectively described as "Sponsors") will not be held responsible for any injury, death, damage, or loss to or by animals or equipment, including without limitation equines, canines, carriages, equipment use, for the care, or use of the animals or equines. This includes, but is not limited to damage by fire, theft, animal, human and/or equipment collision, escape and acts of God.

• In consideration for the privilege of participating in activities related with the activities located on or related to the Sponsors' property, equipment, equines, or animals, the undersigned Releasors expressly agree to assume the risk for any and all injury, loss or damage and agree to release, hold harmless, and indemnify Sponsors, together with all their agents/employees from any and all claims of injury, loss, damage or death caused by, resulting from or in any way related to the inherent risks of equine activities.

• Releasors agree that all farrier, veterinarian and medical expenses, including emergency care treatment are the sole responsibility of the owner of the animals on behalf of whom such services are rendered.

• Releasors expressly covenant not to sue or make claim against Sponsors, their heirs, successors, assigns, agents, servants or employees for any injury, loss, damage or death caused by, resulting from, or in any way related to any of the inherent risks of equine activities.

• Should any individual provision of this release agreement be declared null, void and unenforceable, all other provisions shall be in full force and effect. In the event of any claim or litigation arising out of this agreement, the prevailing party shall be entitled to attorneys' fees and costs. This is a legally binding agreement and each party has the right to seek and obtain the opinion of separate counsel before executing this document.

• Consumption of alcohol is not permitted during Florida Whips events.
